Caring Action for Children Celebrates 50 years of Service

How one family can make a difference

Caring Action is celebrating its 50th anniversary this year and we would like to mark this anniversary by telling a little of the story of the Jansen family and their on-going support of this ministry.

It was **Trygve Jansen** that started it all. He moved to Los Angeles in 1950, attended UCLA and began a long teaching career. Through his work he learned about the problems that many Mexican children and families faced, both in the USA and in Mexico.

At his school he established a small group of colleagues that contacted the people that were running the work at the children's home called Mama Paulita in Mexico. At that time there were 11 girls at the home. He made agreements to participate in this ministry, and began working to raise money for the running of the Home – and in this way Caring Action started.

In the beginning, Trygve turned to family and friends in order to start the work of spreading information and encouraging people to donate to the Home in Mexico. His elder brother, **Olaf Jansen**, volunteered for the job as treasurer in Norway, and served until about 1980 when his health took a turn for the worse. In 1981, **Turid Askevold**, Trygve and Olaf's niece, took over the job. She has been the treasurer for Caring Action in Norway since that time.

Harald Jansen, another brother of Trygve's, and the father of Turid, took the job of writing and producing the Norwegian newsletter.

In 1986, Trygve died while he was visiting the Children's Homes in Mexico. **Tor Jansen**, the nephew of Trygve, had heard God's calling, and agreed to serve as the new Executive Director of Caring Action. At the time Trygve passed away, Tor had just retired at the age of 55 years. He decided to dedicate the rest of his life to the work of helping the many abandoned and orphaned children in Mexico. He passed away in 2013, completing his work after 27 years of unique dedication to the work for Caring-Action.

During the period of Tor's leadership, **Susan Fiske**, daughter of Trygve, participated in the work as treasurer for 15 years.

Shirley Becker – also a niece of Trygve, has served on the Board of Directors since 1997. Since Tor passed in 2013, she has carried out the tasks of coordination of the work in the USA and Mexico. In Norway, **Helge Jansen** – son of Harald Jansen and nephew of Trygve – has been the leader of the work since 1991. Tor's daughter, **Mia Varone**, has served as Donation Secretary since 2003, and also became a member of the Board of Directors this year. Tor's grandson, **Josh Varone**, serves on the Board of Directors and assists with Tech and Media support (see the back for more information about Josh).


